4	Soma Flora CBD Oil - 30 ml (oil) Cannabinoids (1500 mg) , 30 ml [1 unit]	2 application	0-0-1 Before Bedtime	1 Month	Take 2 application - at night, before bedtime, for 1 month. 2 drops, 1 hour before going to bed, Sublingual
