I am regretful to encroach upon your valuable time and busy schedule, however situation made me compel to inform you regarding the misbehavior of Dr.P.K.Goswami.

As your kind self is aware, I am serving our reputed organization since 09.11.2020 as Associate Professor and assumed the duty as Head of the Department(As per the notification received from joint registrar general administration on 22.02.21 reference number No. R/GAD/II-HOD(89/30082). I have been performing all my fixed duties and responsibilities at the best of my abilities and have a good track record in all aspect.

Since, I am having partial acceptance issue from the senior faculty member of the department from beginning of joining. Dr.Sudama Singh Yadav, Assistant Professor was my competitive candidate in the selection process, although I got selected through interview. Dr.M.Paliwal,

Professor (CAS) former Head of department, was not comfortable to accept me as head of the Department. There were minor issues but any how managed because those issues were restricted to the departmental official matter.

Dr.P.K.Goswami, Professor, Department of Samhita and Sanskrit, was on deputation and repatriate to parental institute BHU on 23.08,2021. Being a senior faculty of department personally I welcomed sir to the institute as well as to the department, followed with unofficial meeting of all faculty members later on.

With agony am expressing that, from very next day of joining (23.08.2021) his behavior was not up to the mark and he posed himself as supreme of the department. Sir was invited all the faculty member to seminar hall of the department and started criticizing me in undeniable manner in front of all the junior and senior faculty member. Without considering that even am female he started used many unfastened abusing words, addressing me in singular way and insulting manner. Sir started insulting me through destructive criticism to make me guilt in front of all subordinates. Pointing me repeatedly that am not worthy for the post which I presently perceiving. Demotivated me by constant mentioning of my significant consequences, personal and financial matter. He also remind me frequently that am the future dean of the faculty, he will not allow me even to complete my professional period also.

Later on I am getting regularly abused and threatening by him, saying that 'you took thirteen years to develop your career; I will destroy your career as well as character within short period. Kaat ke phekh dunga, goli maar dhunga' He is compelling me by keeping demand of many unacceptable factors.
