Subject: Regarding academic harassment by Head of the Department, Rasa Shastra, FoA, IMS, BHU

Respected Sir,

I, Dr. Namrata Joshi, faculty member in the Faculty of Ayurveda, BHU, am facing deliberate harassment from my Head of the Department. In this regard, I wish to point out on a recent incidence.

- Recently I had been invited at Govt. Ayurveda College, Patna, to deliver a Keynote lecture on 25th of Dec, 2019. Till the morning of 24th Dec, 2019, when I was scheduled to start my journey, the organizers were in direct contact with me and they ask about my itinerary and other requirements. On the same day around 12 noon, when my application was reached to my Head for sanction of leave, he sanctioned the leave on paper but forced the organizer to cancel my lecture with a threat that he will not be the part of the same event as he was also invited as one of the keynote speaker in the same event.
- I got the information not only from the organizer of the event but he himself confess this when I raised my concern in front of him.
- He further adds that it is the compulsion for him to call me for staff council or any other official meetings, otherwise he will not share any platform with me. From the programme schedule it is very clear that both of us have different session for our address, then where come the situation to share the same stage? Sir, is it not the way to prevent me to flourish?
- From the past four and half year, since I have joined this department, I have been experiencing so many incidents of his indecent behavior. He has used phrases like तुम्हारी औकात क्या है, में पावरफुल हु, तुम यहाँ से रिजाइन दे दो etc. etc. I struggled hard even to get a separate chamber for sitting in the department.
- This is a fresh incidence where he used his power to demolish my career. In the past, he has already been charged for his indecent behavior and one such matter is still subjudiced.


- Deliberate withdrawal of my name to deliver a lecture from a National seminar is not matter of my personal prestige, but it also ruins the name of our University.

I am extremely sorry to put on record that I feel, I am being harassed, humiliated and discriminated for being a women. So, I request you to kindly look into the matter as BHU being such a prestigious University, women employee should not be treated in this way as is happening in our department.






