This is in the history of the department that a female has taken on such an esteemed responsibility not only at BHU but at other prestigious institutes like ITRA, Jam Nagar, the National Institute of Ayurveda, etc.

Greetings of the Day!This is about my earlier communication [Ref.No.RS & BK/ 2024-25/121](#)

dated 31.07.2024, I wish to draw your kind attention to that as per the 2024 NCISM Gazette notification the college shall have a well-equipped teaching pharmacy with proper training facilities for students. Keeping this view together with the mandatory requirement of Ayurvedic pharmacy for UG /PG training as a course curriculum by NCISM, the statutory body for Ayurveda, **the administration of BHU has linked this post with the head of department Rasa Shastra. Sir, I assumed the charge of Head, Dept. of Rasa Shastra on 23-07-24 but still not given the charge of the Pharmacy.** Towards the existing practice, Superintendent Ayurvedic Pharmacy will also rotate similarly to other posts in the university like Head, Dean, Director, etc.

About my communication made in this regard, I came to know that the **administration is in the opinion of bad performance** by the previous superintendent. Sir, I **humbly request you kindly enquire** to find out the lacunae.

Recently a tender quotation is being published for the purchase of Ayurvedic medicines as an indication of stopping the services of the pharmacy which is against the **MAHAMANA'S vision** and ministry of **AYUSH, government of India. Such decisions may badly influence the UG /PG teaching and in-house medicine supply to the hospital. In the future, we may even suffer from recognition issues related to the department.**

Through this letter, I request you to kindly continue the existing practice as made by the BHU administration and allow me to serve as the **first female Superintendent of Ayurvedic pharmacy.** We assure you that we shall do our best to expedite quality medicines from Ayurveda Pharmacy. This will also open the path for future generations/successors of the department of Rasa Shastra and also help the UG /PG scholars to explore more opportunities in their future endeavors.

I wish to personally meet you if you kindly give me time for a meeting for the plans which may be implemented for the upliftment of the existing practices. Hoping for a positive response on your part.

With due respect I am bringing to your kind notice that with deep pain and grief, I am writing with regard to delay in release of my appointment letter as Superintendent, Ayurvedic Pharmacy, BHU.

Sir, in this connection I have submitted my requisition letter to GAD duly forwarded ([Ref.No.RS & BK/2024-25/121](#) dated 31.07.2024) followed by personal meetings with you. However no action is taken. Further, today it came to my knowledge that recommendation of names of some other faculty members from the faculty and the department has been sent by the Dean, Faculty of Ayurveda.

Sir, **Ayurvedic Pharmacy is under the purview of Director, IMS and Dean, Faculty of Ayurveda** has no role as per the **BHU ACT**. Moreover, based on recommendation of competent authority of BHU, it has been previously resolved that the charge of the Ayurvedic Pharmacy will be **Sue-moto is** given to the **Head of the department, Rasa Shastra**. This is in practice since many years but this time when for the **first time a female** has assumed the office as a Head, instead of promoting her for her best tenure, **deliberately she has been stopped to assume the charge**.

You being new in BHU administration, I humbly request to you to please review the files regarding Ayurvedic Pharmacy during the regime of **previous Directors**, namely respected Prof. Gajendra Singh sir, Prof. VP Singh, Prof TN Mohapatra sir and others. It is a humble submission to do justice in my case otherwise a **honest, non-fearing lady who wish to work enthusiastically** for her department and the Pharmacy in spite of all odds she is facing will definitely be **demoralized**.

If justice is done it becomes inevitable for me to bring this matter in the notice of **National commission for woman, Government of India** for the safeguard of **my rights**.
