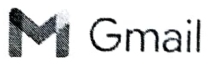

Myself Prof. Namrata Joshi, Head, Department of Rasa Shastra, raised few queries related to the prethesis submission. The director, IMS forwarded this issue to Dean Research, but without examining the facts, the Dean Research has instructed to the Dean, FoA to conduct the DRC meeting in the chairmanship of Dean, FoA. The high intention in this regard is to avoid technical issues which may arise during the final submission and even after in the future too. But without addressing the issues that arise, the DRC was conducted without any reasonable ground, completely bypassing the Head of the department.
