Subject: Regarding continuous mental harassment by Head, Dept. of Rasa Shastra, Faculty of Ayurveda, IMS, BHU, Varanasi.

Respected Sir,

With due respect, this letter is in continuation of my previous grievance letter submitted on 29th Dec 2019, (encl.-1) regarding continuous academic and mental harassment by my HOD.

Respected sir, even after my above-mentioned complaint letter, no action has been taken and my HOD continued with his deeds since then. In this regard, I met you in person in June, at your office and you suggested me to ignore and do your research and academic work. I followed your valuable suggestions, but very recently, again he made public comments about me in a gathering in my department in front of faculty members and students, including my husband, who is also a Ph.D. scholar in the department.

After this incidence, I met The Dean, Faculty of Ayurveda, and narrated the incident. He too advised me to ignore and again I did the same. But what is the outcome of my silence sir?

Very recently, some faculty member wrote something on Facebook (encl.-2), which was not related to me in any case and nor I put any remarks there. As it is a public platform, somebody wrote in favour of that statement with certain quotes (encl.-3), that was again his/ her view. In response to that, my HOD, wrote a comment directly questioning my Ph. D. degree, which I have received as per the scheduled norms of UGC very recently. Sir, who my Head is, to put such a deliberate comment on my Ph.D. degree, which has been awarded from a university (encl.-4) that's too in a public platform. In case he had any doubts about my Ph.D. degree, he could have sought it from the concerned university.

Sir, can a Facebook comment written by a junior colleague, (what may be the context) should be taken to such extent by a senior? Can a person who himself is demanding strong disciplinary action against someone's Facebook comment himself have got the authority to write any derogatory comment on someone's Ph.D. degree? Or make financial charges on some other colleague? In that case too, strong disciplinary action is needed against him.

Sir, I was enrolled and registered in Ph. D course, before joining at BHU and mentioned this fact as and when required. Recently, when I received my degree, I intimated the concerned authority at BHU to add to my file. For this, if somebody is writing that I am trying to add my degree which is not as per UGC guidelines, in the public domain, is this not mental harassment?

r, since 2015, when I joined the department, I have been continuously tortured. On your valuable suggestion to keep going and do your work, I was following the same. But, if somebody is trying to ruin my career, should I ignore sir?

s, I am in deep mental torture due to such continuous activities of my head. So, I again request you to kindly look into the matter and take strong steps so that such incidences will not be repeated with a
